"Telehealth and Your Practice" Workshop Presenters



Sarah King, Ph.D., is a graduate of the University of Nebraska's Clinical Psychology Ph.D. program. She has experience in a variety of settings and is currently in private practice. Her specialty areas include substance abuse and neurodevelopmental disorder evaluations. Sarah also provides consultation, training, and supervision to agencies and their staff, with a particular emphasis in promoting the use of evidence-based approaches.

Sarah has been Secretary of the Nebraska Psychological Association (NPA) Board since 2017 and is a founding member of the Early Career Psychologist (ECP) committee. Through her involvement on the NPA board and ECP committee, she works to address the concerns of Nebraska psychologists. Some areas that Sarah is particularly focused on include reimbursement concerns (e.g., telehealth, psychological evaluations) and the importance of Nebraska consumers having the benefit of psychology's involvement in substance use evaluation and treatment. In addition to Sarah's involvement in NPA, she is a prior member of the Research Society on Alcoholism (RSA) and has previously served on the RSA membership committee.



Jerry Walker, Ph.D., ABPP, is a board-certified counseling psychologist who currently works as the Psychology Services Manager for Nebraska Medicine in Omaha. Dr. Walker received his undergraduate training from the University of Texas and his PhD in Counseling Psychology & Human Systems from Florida State University. He then served 6 years with the United States Air Force, holding multiple leadership positions including: managing an outpatient substance abuse treatment program; serving as the director of a large, multidisciplinary outpatient mental health clinic; orchestrating an installation suicide prevention program; leading a disaster behavioral health team in a deployed setting in the Middle East; and serving as the chief medical officer for a military intelligence organization with 19 worldwide operating locations. Dr. Walker moved to Nebraska with his wife and son to be closer to family.

In addition to his role at Nebraska Medicine, Dr. Walker also "sees" patients via telehealth in 3 states, and he is currently pursuing a Postdoctoral Master's degree in Clinical Psychopharmacology. His professional areas of expertise are: trauma recovery and growth, individual and organizational resilience, and organizational psychological consultation.
